1. Use of Wix Platform:

Our website (www.charterphoenix.com) is hosted on the [Wix.com](https://wix.com) platform, which provides HTTPS and SSL encryption for all data submitted.

Wix Security and Privacy Statement Overview

- Wix employs a dedicated security team that monitors threats, performs audits, penetration tests, and risk management.
- Wix complies with top industry standards: PCI DSS Level 1, SOC2 Type 2, ISO 27001, and more.
- Data centers are hosted on AWS and Google Cloud with strict physical and digital security controls.
- User data is encrypted (AES-256) at rest and protected in transit with HTTPS and TLS 1.2+.
- Wix supports two-factor authentication for added account security.
- Wix has a Law Enforcement Request Policy to protect user data from unauthorized disclosure.
- Privacy controls and GDPR/CCPA compliance tools are available to site owners.

In addition to Wix's general protections, we take extra care with any personal data you provide, including passport images for BVI travel. We use secure upload forms and ensure that all data is stored and accessed only as needed for your charter arrangements. Once the charter has occurred, we periodically purge all passport images from our computers.

Manifests submitted through the Online Clearance Portal are reviewed by Immigration staff. All arrivals must be registered a minimum of one hour before arriving in the British Virgin Islands.”
